On the day of admission, Students are requested to bring the following documents (in original) :

- 1. Class 10<sup>th</sup> admit card.
- 2. Class 10<sup>th</sup> marksheet.
- 3. One passport size photograph.
- 4. Caste certificate, if any.
- 5. EWS certificate, if any.
- 6. PWD (Specially abled) certificate, if any.
- 7. Extra-curricular certificate if any.
- 8. Income certificate issued by local Revenue circle officer, if any.
- 9. Gap certificate if any.

#### **Admission Fee :**

The admission fees as mentioned in the college prospectus available in college website must be deposited at the college office on the day of admission.

### **Important Information**

- The whole admission process will be conducted via darpan portal https://darpan.ahseconline.in
- Admission fees for HS courses will be as per Government regulations.
- Reservation policy will be followed as per Government rules. The supporting document for reservation has to be issued only by the competent authority under the Government of Assam.

### FEE WAIVER SCHEME :

- As per Government Notification vide <u>No. PC/HE/Misc/42/2020/235</u> dated 29<sup>th</sup> June 2022 and <u>No. PC/HE/Misc/42/2020/51</u> dated 6<sup>th</sup> September 2021, *fee waiver is applicable for admission for the session 2023-24 under Pragyan Bharti scheme.*
- For availing fee waiver, annual parental income should be less than Rs. 2.00 lakh from all sources.
- If either parent (mother or father) of the student is working in the state Govt./Semi Govt./State or Central Govt. Undertakings, such students cannot avail the fee waiver.
- Candidates seeking fee waiver must produce their (i) original Marksheet, (ii) income certificate from the local Revenue circle officer, (iii) A declaration from the students that neither of the parents (father or mother) is an employee of State /Central Govt. Department or its undertaking, (iv) photograph of sapling plantation at his/her college or home.
- Those who are not allowed by the admission committee of the college for fee waiver, can take admission by paying the normal admission fee.
- The decision of the college regarding fee waiver will be considered final and binding.
